2. The tenders should be sealed with sealing wax and addressed to Principal Sainik School Kazhakootam, Trivandrum Dist. The following words will be written on the cover of the tender “ **Tender for High Jump Pole Vault pit, School** ”.

3. Tenders will be accepted in the offices of the Registrar, Sainik School Kazhakootam up to **1.00 PM on 10.08. 2010**. Every correction on the tender should be initialed by the tenderer failing which the tender is liable to be rejected. The Principal reserves to himself the right to accept any tender either partly or in full and to reject any or all tenders without assigning any reason. The acceptance or otherwise of tenders will be communicated to the tenderer in writing.

4. Earnest money deposit Rs 3,500/-/- Earnest money deposit should be in the form of Bank Draft drawn in favour of Principal Sainik School Kazhakootam, payable at Kazhakootam / Trivandrum. The successful tenderer will be required to supply the items and install the item within 60 days of issue of supply order. For infringement of the stipulations of the contract, the contractor shall be liable for all losses sustained by the school. The rate of items quoted should included all taxes.

5. Income Tax will be deducted from the bill as per the existing income tax rules from time to time (US206 of IT Act 1961 Rule 371 Section 194 C). Permanent Account Number is mandatory, failure to which attracts 20% TDS. In the event of any dispute of difference and also respect of any matter which is not specifically provided for in the tender, the decision of the Principal, Sainik School will be final and binding in all parties.

6. The tender is to be submitted in this form itself with the name and full address of the tenderer. This paper duly completed by the tenderer in all respects must be returned to the under signed without tearing any part of it. Final settlement of the bill will be made only after completion of supply and approval by the school authorities. **No advance payment will be made.**

7. Your client list should be attached along with tender forms. Rates quoted should include all taxes, freight charges, Installation charges , other cost if any. No other addition to your rates will be accepted during price negotiation. The tender form should be enclosed with product catalogue, brochures etc. for reference C D alone will not be accepted. ISI, ISO certificate may also be quoted.
